WEALTH TO ME was unhurried into stride, responded when put to pressure with three furlongs to run, closed swiftly circling five wide, brushed GHOSTWALKING entering the stretch, forged command nearing the furlong marker, drifted out through the drive, dug in to meet the challenge of RAVEN HAWK with a sixteenth to run, bumped with that one late and was all out to prevail by the narrowest margin. RAVEN HAWK settled in hand between horses, was hemmed in and waited leaving the second turn, wheeled to the outside entering the stretch, drew even inside the furlong marker, was carried out through the drive, bumped with WEALTH TO ME near the wire and was kept at bay. GHOSTWALKING stalked the pace three deep, launched his bid leaving the second turn, loomed a danger entering the stretch, was brushed by the winner and flattened during the drive. BLESS ME FATHER was rank to place, pulled to the lead and contested the pace three wide, faltered between horses entering the stretch and faded. FIRST GOLD sent to the fore, angled in to set the pressured pace, disputed the issue to the stretch and tired. MOUNT DOLLBERG was forwardly placed along the inside, but came up empty leaving the second turn and dropped out. TOULOUSEONTHELOOSE saved ground to no avail. The jockey of RAVEN HAWK lodged an objection against WEALTH TO ME for alleged interference in the stretch run, but following the Stewards review there was no change to the order of finish.
