DESERT LORD rated off the pace, raced four wide around the far turn, then rallied while lugging in through the stretch to be up late. KEROUAC reserved off the pace, was advancing along the rail when caught in tight entering the far turn, eased outside REMITTANCE and rallied to take over entering the stretch but couldn't resist the winner in the closing strides. CITY WOLF stalked the pace three wide, moved to gain a brief lead nearing the quarter pole, then weakened in the drive. REMITTANCE bobbed at the start, set the pace along the inside to past midway of the far turn, then tired. PAPA DAVE off slowly, was never a factor. MYSTIC was stalking the pace when steadied to avoid running up on the leader on the first turn, continued to stalk the pace into the far turn, then faltered.
